Or, the complete text of a document can be read to allow full-text retrieval—a great research tool for documents like contracts, agreements, and minutes.

The Advanced Templates and OCR Module also includes these Automated Document Preparation features:

- Blank page removal automatically eliminates blank pages in documents, making viewing and printing more efficient.
- Scheduled upload of remotely-scanned documents optimizes utilization of your network bandwidth.
- Barcode separator pages\* indicate the beginning of documents and automatically select a template to reduce effort and errors when filing.
